CALL TO ORDER

Dr. Carolyn Evans-Shabazz, Committee Chair, called the meeting to order at 1:30 p.m. and declared the Board convened to consider matters pertaining to Houston Community College as listed on the duly posted Meeting Notice.

Dr. Maldonado noted that the College has been working with the Kinder Foundation regarding funding for the OER and Z-Degree initiatives. He apprised that Dr. Beatty and her team would provide a report on the OER and Z-Degree.

Dr. Beatty recognized her team and apprised that Dr. Steve Levey, Associate Vice Chancellor of Academic Instruction would provide an overview on the Open Educational Resources (OER) and Z-Degrees.
