- 1.4 Sealed Proposals shall be delivered to the address noted above by the referenced due date.
- 1.5 HCC's General Terms and Conditions of Purchase Order dated February 9, 2018, shall govern any purchase order/contract that may result from this request. A copy is available and posted on the HCC website at <u>HCC</u> <u>General Terms and Conditions</u>.

## 1.6 Specifications

## 2. Vendor Selection

Except as provided by the Texas Education Code, Subchapter B, in determining to whom to award a contract, the District shall consider:

- 2. The reputation of the vendor and of the vendor's good or services;
- 3. The quality of the vendor's goods or services;
- 4. The extent to which the goods or services meet with the College's needs;
- 5. The vendor's past relationship with the College;

- 6. The impact on the ability of the College to comply with laws and rules relating to historically underutilized businesses;
- 7. The total long-term cost to the College to acquire the vendor's goods or services;
- 8. For a contract for goods and services, other than goods and services related to telecommunications and information services, building construction and maintenance, or instructional materials, whether the vendor or the vendor's ultimate parent company or majority owner:
  - a. Has its principal place of business in this state; or
  - b. Employs at least 500 persons in this state; and
- 9. Any other relevant factor specifically listed in the request for bids or proposals.

This section does not apply to a contract for professional services rendered, including services of an architect, attorney, certified public accountant, engineer, or fiscal agent. The District may, at its option, contract for professional services rendered by a financial consultant or a technology consultant in the manner provided by Section 2254.003, *Government Code*, in lieu of the methods.

## 3. General Information

- 3.1 A person is not eligible to be considered for award of this solicitation or any resulting contract or to be a subcontractor of the proposer or prime contractor if the person assisted in the development of this solicitation or any part of this solicitation or if the person participated in a project related to this solicitation when such participation would give the person special knowledge that would give that person or a prime contractor an unfair advantage over other proposers.
- 3.2 A person or proposer shall not be eligible to be considered for this solicitation if the person or proposer engaged in or attempted to engage in prohibited communications as described in Section 3.9 - Prohibited Communications and Political Contributions.
- 3.3 Award Approval this Procurement, any award under this procurement, and the resulting purchase order/contract, if any, is subject to approval by HCC Board of Trustees. Subsequent to Board approval, the only person authorized to commit HCC contractually is the Chancellor or designee. This solicitation is a formal Request for Proposal and neither this solicitation nor the response or proposal from any prospective proposer shall create a contractual relationship that would bind HCC until such time as HCC has issued a legally binding purchase order/contract, which includes, without limitation, the terms required by HCC as set forth in this Request for Proposal.
- 3.4 HCC Contact any questions or concerns regarding this Request for Proposal shall be directed to the Procurement Officer listed on the cover page. HCC specifically requests that proposers restrict all contact and questions regarding this Request for Proposal to the Procurement Officer. The Procurement Officer must receive all questions or concerns no later than the date and time listed in the Solicitation Schedule.
- 3.5 Inquiries and Interpretations responses to inquiries, which directly affect an interpretation or change to this Request for Proposal, will be issued in

writing by addendum (amendment) and all addenda will be posted on the <u>HCC Procurement Website</u>. All such addenda issued by HCC prior to the time that proposals are received shall be considered part of the Request for Proposal, and the proposer shall be required to consider and acknowledge receipt of such in their proposal.

Only those HCC replies to inquiries, which are made by formal written addenda, shall be binding. Oral and other interpretations or clarification will be without legal effect. Proposer must acknowledge receipt of all addenda in Attachment No. 1 Request for Proposal Form.

- 3.6 Contract Award award of a contract, if awarded, will be made to the proposer who (a) submits a responsive proposal; (b) is a responsible proposer; and (c) offers the best value to HCC, price and other factors considered. A responsive proposal and a responsible proposer are those that meet the requirements of and are as described in this solicitation. HCC may award a contract, based on initial proposal received, without discussion of such proposers. Accordingly, each initial proposal should be submitted on the most favorable terms from a price and technical standpoint, which the proposer can submit to HCC. Except as otherwise may be set forth in this solicitation, HCC reserves the right to informalities, non-material errors, waive anv technicalities, or irregularities in the proposal documents submitted and consider for award.
- 3.7 Postponement of Proposals Due Date/Time notwithstanding the date/time for receipt of proposal established in this solicitation, the date and time established herein for receiving proposals may be postponed solely at HCCs discretion.
- 3.8 Internship Program HCC is expanding its student internship program. All proposers are encouraged to make a commitment to utilize certain HCC student(s) in an internship capacity with the company under any

resulting contract for the items required under this solicitation. At the sole discretion of the vendor, the internship opportunity may be paid or unpaid and shall be intended to serve as a relevant and meaningful educational enrichment opportunity for the HCC students involved. HCC will provide the selected proposer with the name of student(s) eligible to participate in the internship program.

3.9 Prohibited Communications and Political Contributions – except as provided in exceptions below, political contributions and the following communications regarding this solicitation or any other invitation for bids, requests for proposal, requests for qualifications, or other solicitation are prohibited:

[1] Between a potential vendor, subcontractor to vendor, service provider, respondent, Offeror, lobbyist or consultant and any Trustee;

[2] Between any Trustee and any member of a selection or evaluation committee; and

[3] Between any Trustee and administrator or employee.

The communications prohibition shall be imposed from the day the solicitation is first advertised through thirty (30) days after the contract is executed by the Chancellor or his/her designee, or when a determination is made that the contract will not be awarded. During this period, no HCC Trustee and no vendor shall communicate in any way concerning any pending Solicitation involving the Vendor, subject to the penalties stated herein.

In the event the Board refers the recommendation back to the staff for reconsideration, the communication prohibition shall be re-imposed.

The communications prohibition shall not apply to the following:

[1] Duly noted pre-bid or pre-proposal conferences.

[2] Communications with the HCC General Counsel.

[3] Emergency contracts.

[4] Presentations made to the Board during any dulynoticed public meeting.

[5] Unless otherwise prohibited in the solicitation documents, any written communications between any parties, provided that the originator shall immediately file a copy of any written communication with the Board Services Office. The Board Services Office shall make copies available to any person upon request.

[6] Nothing contained herein shall prohibit any person or entity from publicly addressing the Board during any duly-noticed public meeting, in

accordance with applicable Board policies, regarding action on the contract.

Any potential vendor, subcontractor vendor, service provider, proposer, offeror, lobbyist or consultant who engages or attempts to engage in prohibited communications shall not be eligible for the award of any resulting contract under this solicitation. Any other direct or indirect actions taken to unduly influence competitive purposes, to circumvent equal consideration for competitive proposers, or to disregard ethical and legal trade practices will disqualify proposers, vendors, service providers, lobbyist, consultants, and contractors from both this current and any future consideration for participation in HCC orders and contracts.

- 3.10 Drug Policy HCC is a drug-free workforce and workplace. The manufacture, sale, distribution, dispensation, possession or use of illegal drugs (except legally prescribed medications under physician's prescription and in the original container) or alcohol by proposers or contractors while on HCC's premises is strictly prohibited.
- 3.11 Taxes HCC is tax exempt as a governmental subdivision of the State of Texas under Section 501C (3) of the Internal Revenue Code. Limited Sales Tax Number: 1-74-1709152-1. No proposal shall include any costs for taxes to be assessed against HCC. The proposer shall be responsible for paying all applicable taxes and fees, including but not limited to, excise tax, state and local income tax, payroll and withholding taxes for proposer employees. The purchase order/contract shall hold HCC harmless for all claims arising from payment of such taxes and fees.
- 3.12 Texas Public Information Act HCC considers all information, documentation and other materials requested to be submitted in response to this solicitation to be of a non-confidential and/or nonproprietary nature, and therefore, shall be subject to disclosure under the Texas public Public Information Act (Texas Government Code, Chapter 552.001, et seq.) ("The Act") after a contract if any, is awarded. If the proposer considers any information submitted in response to this Request for Proposal to be confidential under law or constitute trade secrets or other protected information, the proposer must identify such materials in the proposal response. Notwithstanding the foregoing, the identification of such materials would not be construed or require HCC to act in contravention of its obligation to comply with the Act and the proposer releases HCC from any liability or responsibility for maintaining the confidentiality of such documents.

- 3.13 Appropriated Funds the purchase of service or product, which arises from this solicitation, is contingent upon the availability of appropriated funds. HCC shall have the right to terminate the resulting contract at the end of the current or each succeeding fiscal year if funds are not appropriated by the HCC Board of Trustees for the next fiscal year that would permit continuation of the resulting purchase order/contract. If funds are withdrawn or do not become available, HCC reserves the right to terminate the resulting purchase order/contract by giving the selected contractor a thirty (30) day written notice of its intention terminate without penalty or any further obligations on the part of HCC or the contractor. Upon termination of the purchase order/contract HCC shall not be responsible for any payment of any service or product received that occurs after the end of the current contract period or the effective date of termination, whichever is the earlier to occur. HCCs fiscal year begins on September 1 and ends on August 31.
- 3.14 Conflict of Interest if a firm, bidder, proposer, contractor, or other person responding to this solicitation knows of any material personal interest, direct or indirect, that any member, official, or employee of HCC would have in any contract resulting from this solicitation, the firm must disclose this information to HCC. Persons submitting a proposal or response to this solicitation must comply with all applicable laws, ordinances, and regulations of the State of Texas Government Code, including, without limitation, Chapter 171 and 176 of the Local Government Code. The person /proposer submitting a response to this solicitation must complete (as applicable), sign and submit Attachment No. 3, Conflict of Interest Questionnaire Form, and Attachment No. 4, Financial Interest and Potential Conflict of Interests with the proposal package. HCC expects the selected proposer to comply with Chapter 176 of the Local Government Code and that failure to comply will be grounds for termination of the contract.

Note: Attachment No. 3 and Attachment No. 4 shall be completed signed and returned to HCC. Enter N/A in those areas on the Attachments that are not applicable to your company. Failure to complete, sign and notarize (if applicable) these Attachments may render your proposal non-responsive.

3.15 Ethics Conduct – any direct or indirect actions taken to unduly influence competitive purposes, to circumvent equal consideration for competitive proposers, or to disregard ethical and legal trade practices will disqualify vendors and contractors from current and future consideration for participation in HCC orders and contracts.

- 3.16 No Third Party Rights the resulting purchase order/contract is made for the sole benefit of HCC and the Contractor and their respective successors and permitted assigns. Nothing in this Purchase Order/Contract shall create or be deemed to create a relationship between the Parties to this Purchase Order/Contract and any third person, including a relationship in the nature of a third party beneficiary or fiduciary.
- 3.17 Withdrawal or Modification no proposal may be changed, amended, modified by telegram or otherwise, after the same has been submitted or filed in response to this solicitation, except for obvious errors in extension. However, a proposal may be withdrawn and resubmitted any time prior to the time set for receipt of proposals. No proposal may be withdrawn after the submittal deadline without approval by HCC, which shall be based on proposer's submittal, in writing, of a reason acceptable to HCC.
- 3.18 Submission Waiver by submitting a response to this Solicitation, the Offeror or respondent agrees to waive any claim it has or may have against Houston Community College System and its trustees, employees or agents arising out of or in connection with (1) the Administration, evaluation or recommendation of any offer or response; (2) any requirements under the solicitation, the solicitation or response package or related documents; (3) the rejection of any offer or any response or any part of any offer or response; and/or (4) the award of a contract, if any.
- 3.19 Indemnification proposer shall indemnify, pay for the defense of, and hold harmless the College and its officers, agents and employees of and from any and all liabilities, claims, debts, damages, demands, suits, actions and causes of actions of whatsoever kind, nature or sort which may be incurred by reason of proposer's negligence, recklessness, or willful acts and/or omission in rendering any services hereunder. Proposer shall assume full responsibility for payments of federal, state and local taxes or contributions imposed or required under the social security, Workers' Compensation or income tax law, or any disability or unemployment law, or retirement contribution of any sort whatever, concerning Contractor or any employee and shall further indemnify, pay for the defense of, and hold harmless the College of and from any such payment or liability arising out of or in any manner connected with Contractor's performance under this Agreement.
- 3.20 Delegation unless delegated, HCC Board of Trustees must approve all contracts valued at over \$100,000. The Board has granted the Chancellor

authority to initiate and execute contracts valued up to \$100,000. The procurement of goods and services, including professional services and construction services shall be completed as per any applicable HCC policy and procedure and shall be in accordance with Section 44.031 of the Texas Education Code for the purchase of goods and services, Section 2254 of the Texas Government Code for the purchase of Professional and Consulting Services, and Section 2269 of the Texas Government Code for the purchase of construction services. The Board delegates its authority to the administration and the designated evaluation committee to evaluate score and rank the proposals. This includes the evaluation of all propoals, proposals, or statements of qualification under procurement, regardless of contract amount, including the final ranking and selection which shall be made on the evaluation and scoring as per the published selection criteria and the final evaluation ranking. The Board of Trustees shall approve the final award of contracts to the firm based on the published selection criteria and as evidenced in the final evaluation, scoring and ranking.

3.21 Invoice – to facilitate payment, invoices for goods or services delivered in accordance with the resulting purchase order/contract shall be emailed to the Accounts Payable Department with copy to the Small Business Development Program. Pursuant to Texas Law, payment terms shall be net thirty (30) days.

All invoices shall include certified documentation noting any small business participation activity including but not limited to: small business firm's name, certification number, certification expiration date, description of work performed for the corresponding period noted on the invoice and amount being paid to the certified small business. Such documentation shall be certified by the small business and be used to monitor the ongoing small business commitment in accordance with the original proposed commitment and governing contract.

3.22 Cooperative Purchasing Agreement - as permitted under Interlocal Cooperation Act C Texas Government Code, Chapter 791, other governmental entities may wish to also participate under the same terms and conditions contained in this contract. If this solicitation does not specifically list additional entities, each entity wishing to participate must have prior authorization from Houston Community College and the vendor. If such participation is authorized, all purchase orders will be issued directly from and shipped directly to the entity requiring the goods or services. Houston Community College shall not be held responsible for any orders placed, deliveries made or payment for goods or services ordered by the entities. Proposer is to state their willingness to allow other governmental entities to participate in this contract, if awarded.

3.23 W9 Form - Proposer shall include a W9 Form with their proposal submission.

This scope of service covers the requirements for the Supplier to provide all costs for design, labor, all materials, equipment, tools, inspections, and all travel expenses associated with this project, to bring the project to completion for the College, as herein specified.

HCC is requesting bids from qualified vendors for the **design and manufacture of collegiate mascot costumes**. The College anticipates purchasing up to seven (7) mascot costumes over the initial term of the contract. The supplier is required to provide firm fixed pricing over the initial contract term.

In using this method for solicitation, we are requesting your best effort in seeking the best value for our requirements. To be eligible for consideration, proposals shall be presented in accordance with the instructions of this solicitation and within the timeframe specified. It shall be the responsibility of the Bidder to meet all specifications and guidelines set forth herein. HCC, at its discretion, determines the criteria and process whereby proposals are evaluated and awarded. No damages shall be recoverable by any challenger because of these determinations or decisions by Houston Community College.

## 3.1 BIDDER REQUIREMENTS

- 3.1.1 Bidder shall provide their own innovative design and features for the proposed new Swoop costumes. The College is providing photos herein for illustration purposes only.
- 3.1.2 There shall be no additional charges for artwork and the College shall maintain the rights to the artwork.
- 3.1.3 The College also reserves the right to make unlimited revisions to meet brand standards without any additional charges. HCC shall own the rights to the character.
- 3.1.4 The Supplier shall provide a costume sketches for the design of the mascot costume and all design fees must be included in the purchase price of the costume.
- 3.1.5 The Supplier shall provide a cleaning and maintenance program such as annual cleaning, which includes maintenance and minor repairs.
- 3.1.6 The Supplier shall provide the maximum warranty possible against defects. The life span of the fur shall be a minimum of five years. Bidder to include warranty information and confirm in their response that the costume fur meets this requirement.
- 3.1.7 Shipping and handling cost shall be included in the price of each costume and shall be shipped FOB destination, full freight prepaid and allowed.
- 3.1.8 All costumes shall be shipped in a heavy duty protective traveling crate and/or storage cases

## 3.2 MASCOT COSTUME SPECIFICATIONS:

- 3.2.1 General Specifications The costume would be for a character named "SWOOP," an Eagle mascot for collegiate events. The Swoop Mascot costumes shall be constructed of durable, breathable and easily maintainable materials. It shall be flexible in sizing and construction for ease of movement and be made with the ability to be worn by a male or female. The costume would fit a person Five Foot Seven Inches (5' 7") to Six Foot (6').
- 3.2.2 The HCC Swoop Mascot costumes shall have double and extra fortified seams to ensure durability and all seams shall have durable thread to allow for maximum flexibility.
- 3.3 SPECIFIC COLORS:
  - 3.3.1 The mascot costumes colors shall incorporate, Houston Community College's standard colors of <u>Sunshine</u> <u>1253C and Rich Black C: 75 M: 68 Y: 67 K: 90</u> throughout the costume. Pantone colors to provide the best possible match. A color sketch with fabric swatches may be used to determine further details.

Colors used for the mascot shall be the approved colors of the College. The head is <u>Stratus White-C: 0 M: 0</u> <u>Y: 0 K: 0</u> and the body should be Brown. The jersey, gloves and shoes shall be Black and White.

## 3.4 LONG PANT COSTUME WITH LONG SLEEVE JERSEY

- 3.4.1 The long pants shall be black in color and contain **no** fur underneath the pants. Open toe shoes with eagle feet and supplier to provide the option for "Breakaway" pants with snaps.
- 3.4.2 Basic design is a long sleeve jersey with no fur on sleeves. Bidders are encouraged to provide unique dynamic designs for the long sleeve jersey. Both white and black baseball gloves are to be provided.
- 3.4.3 HCC logo on front (Black) on jersey- (HCC to provide the logo). Name of mascot, "Swoop" shall be placed on the back of the jersey in one color.

## 3.5 SHORT PANT COSTUME WITH SHORT SLEEVE JERSEY

- 3.5.1 The short pants shall be black in color and contain fur underneath the shorts and legs. Bidder to also provide an option for no fur under short pants. Open toe shoes with eagle feet and supplier to provide the option for "Breakaway" pants with snaps.
- 3.5.2 Provide short sleeve jersey with fur on the sleeves. Bidders are encouraged to provide unique dynamic designs for the long sleeve jersey. HCC logo on front (one color) on jersey- (HCC to provide the logo). Name of mascot, "Swoop" shall be placed on the back of the jersey in one color.
- 3.5.3 Both white and black baseball gloves are to be provided.

## 3.6 HEAD PIECE

- 3.6.1 The costume head shall be constructed or made out of microcell foam or ETHA Foam and shall not weigh more than 3 pounds. Ventilation would be provided through a screened area in the top of the mascots head. The head and neck shall not be attached to the body and no metal at all shall be used in the head. A street hockey helmet shall be used with inner foam and a chinstrap and shall weigh ½ pound and/or not more than one pound. The helmet padding must be removable.
- 3.6.2 Visibility would be provided through the beak and opening must be big enough to allow for peripheral vision. The mouth must be a wide open mouth and shall not include metal mesh to keep the mouth open. The Supplier is required to provide athletic mesh. The head section must be washable and include carrying bags for head.

## 3.7 BODY

- 3.7.1 The body of the costume, designed in the shape and form of an Eagle similar to photo illustrations contained herein and would be constructed of and sculpted using lightweight athletic material for the costume lining. The ends of the arms need only to come to the wrist and there is no need for hands. Left and right handed white batting gloves are to be included. The feet/sneakers must have internal straps so the performer is able to secure their own shoes inside the costume. The costume should include two feet options, a claw and a shoe cover and the costumes should be made out of deluxe long pile fur or plush fur.
- 3.7.2 The costume should have built in muscles and the costume body shall include a built-in cooling system, in the vest area. The body section must be washable and include carrying bags for body.
- 3.7.3 Bidder to describe in detail cooling system to go inside the costume to keep the inside cool and comfortable, custom carrying bag, and battery-operated cooling fan to go inside the costume.

## 3.8 TAIL

As illustrated in the photos herein. The costume shall include a fain tail. The removable, oversized shoes created of sculpted foam covered with velvet loop fabric, would have internal elastic foot straps for maximum mobility and control and long wearing crepe rubber soles.

#### 3.9 ARTWORK & DESIGN STANDARDS

- 3.9.1 All artwork and colors shall be in compliance with HCC's Branding Guidelines and Standards. Follow this link to HCC Brand Standards: <u>https://hcc-brand-standards/</u>
- 3.9.2 HCC Brand Standards shall be strictly adhered to.
- 3.10 ADDITIONAL CONSIDERATIONS:
  - 3.10.1 The following consideration may assist during the preparation of bid responses:
    - 3.10.1.1 The costume is intended to be used "Year-Round" and used for both indoor and outdoor activities and events;
    - 3.10.1.2 The costume is intended to be extremely and actively used. It is not intended for just a "meet and greet" type of character costume;
    - 3.10.1.3 The costume is intended to be very interactive with all age groups and must have a pleasant, appealing expression and must be mobile. It will be taken to multiple locations, so it must be easily transportable; and
    - 3.10.1.4 The Bidder is required to provide a training video or one on one training for the client.

## 3.11 HCC RESPONSIBILITIES:

- 3.11.1 HCC will inspect completed costume for discrepancies in the construction and workmanship and will notify the Contractor immediately to make arrangements to rectify and/or resolve any issues(s) at no additional charge to the College.
- 3.11.2 HCC will provide logos for the design of the mascot to the selected Contractor. All proof shall be submitted to the College for final review and approval, in writing, prior to the manufacture of the mascot costume. All Artwork and logos shall remain the sole property of the College.

## 4 Additional Information

A bid award, if any, will be through the issuance of an HCC purchase order (PO) and shall be governed by the general terms and conditions of purchase outlined on the HCC PO document unless such terms and conditions are superseded by the content of this Request for Quote (RFQ) or contract (if terms are in conflict, the terms of the RFQ will take precedence).

By submitting a response to this request, the bidder/proposer or accepts the responsibility for downloading, reading and abiding by the terms and conditions set forth in the General Terms and Conditions found on the HCC web site at: <u>https://HCC General-Terms-and-Conditions-of-Purchase-Orders.pdf</u>

The final authority to approve or disapprove delivered products and/or services lies with HCC.

In the event products/services delivered do not meet specification quality level, or do not perform as specified in this bid/proposal, the contractor will replace the items, at no additional cost to HCC.

The bidder shall be responsible for all claims against the manufacturer for manufacturing defects.

Any correspondence regarding a HCC PO, specifically an invoice, must include the PO number to ensure correct and timely processing. Invoices must reference HCC's PO number.

HCC will not be responsible for products delivered or services rendered in advance of a supplier's receipt of a purchase order.

The first year warranty should include all parts and labor, including all necessary on-site labor and all travel expenses for technicians. Routine preventive maintenance visits should also be provided. If repairs are required due to substandard workmanship or defects, the Contractor will make the necessary corrections at its expense at no additional cost to HCC.

The Contractor warrants all items acquired shall conform to all contractors' representations, the requirements of this contract, and all published documentation.

- 6.1 The Contractor shall be required to provide the following Warranty details:
  - i. Describe the warranty period including a detailed description of what is covered and what may be excluded from coverage.
  - ii. Provide detailed description of what is covered and what may be excluded from coverage under the optional maintenance.
  - iii. Identify what type and kind of field support you will provide under this solicitation; if any.
- 7. Added Value

HCC is interested in maximizing the value of expenditures as it relates to achieving additional value that would further benefit HCC and its operation, as well as its community of citizens and their tax based funding. As such, bidders are encouraged to consider, develop and propose added value concepts, programs, components and the like that would further enhance the proposed acquisition represented in this solicitation request.

8. Additions and Deletions

HCC, by written notice to the Contractor, at any time during the term of this contract, may add or delete like or similar equipment to the list of equipment, locations and/or services to be performed. Any such written notice shall take effect on the date stated in the notice from the College. The Contractor will be requested to provide a monthly fee equal to their normal and customary charges or rates for the equipment, locations and/or services requested.

## 9. Estimated Quantities Not Guaranteed

HCC, anticipates purchasing seven (7) collegiate mascot costumes during the initial contract term. The estimated quantities specified herein are not a guarantee of actual quantities, as HCC does not guarantee any particular quantity of collegiate mascot costumes during the term of this contract. The quantities may vary depending upon the actual needs of the user Department. The quantities specified herein are good faith estimates of usage during

the term of this contract. Therefore, HCC shall not be liable for any contractual agreements/obligations the Contractor enters into based on all the quantities specified herein.

10. Additional Services

In the event College may require additional related services to be performed by Contractor that are outside the scope of this Agreement ("Additional Services") it may submit a written request for a proposal from Contractor ("Proposal"), which Contractor may provide if Contractor is willing and able to perform such Additional Services. Such Proposal shall contain (a) the scope of work to be performed; (b) a fixed billing rate for the proposed services; and (c) any other information relevant to such Proposal. Contractor shall deliver such Proposal to College within a reasonable period of time. If such Proposal for Additional Services is acceptable to the College, it will sign such Proposal. College may deny such Proposal at its sole and absolute discretion.




## **Front View**

Notwithstanding any other law, a company that the United States government affirmatively declares to be excluded from its federal sanctions regime relating to Sudan, its federal sanctions regime relating to Iran, or any federal sanctions regime relating to a foreign terrorist organization is not subject to contract prohibition under this subchapter.

## Definitions:

"Business entity" shall not include a corporation or a subsidiary or division of a corporation whose shares are listed on a national or regional stock exchange or traded in the over-the-counter market. "Business entity" shall not include non-profit corporations or religious, educational, and governmental institutions, except that private, for-profit educational institutions are included in the definition of Business entity.

"Director" is defined as an appointed or elected member of the board of directors of a company who, with other directors, has the responsibility for determining and implementing the company's policy, and as the company's agent, can bind the company with valid contracts.

"Officer" is defined as a person appointed by the board of directors of a company to manage the day-to-day business of the company and carry out the policies set by the board. An officer includes, but is not limited to, a chief executive officer (CEO), president, chief operating officer (COO), chief financial officer (CFO), vice-president, or other senior company official, as determined by the Board.

"Senior Staff Member" shall have the meaning as defined in Article A, Section 3 of the Board Bylaws which includes:

- a. Any member of the Chancellor's Advisory Council;
- b. HCC employees classified as E-10 and above;
- c. All procurement and purchasing personnel;
- d. Any employee who participates on an evaluation or selection committee for any HCC solicitation for goods or services; and
