IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER PARTY OR ANY OTHER PERSON FOR ANY SPECIAL, INDIRECT, INCIDENTAL, PUNITIVE OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO, LOSS OF ANTICIPATED PROFITS.

CUSTOMER COOPERATION

2. Scope of covered pests. Would you be open to changing the scope like the example?

Service: Interior and exterior pest management in accordance with the principles of Integrated Pest Management (IPM).

Service Frequency: Twice a Month

Pest Coverage: Rats, mice, cockroaches, common ants, common spiders and occasional invaders (e.g., beetles, centipedes, slugs). Coverage excludes: Asian cockroaches, flies, fired ants, pharaoh ants, carpenter ants, tawny (raspberry crazy ants), birds, bed bugs, termites, and fumigation treatments. (Excluded pest can be serviced under separate contracts with unique guarantees and service protocols.)

(With this format you only pay for bed bug treatments if they occur or bees mosquitos, etc.)

Answer: The Scope is as stated in the solicitation.
